SCOPE

With an unlimited program ceiling and a five-year base period, a five-year option and the ability for awarded task orders to run an additional five years (through March 9, 2041), Alliant 3 allows for large-scale program requirements and long-term planning.

The scope of Alliant 3 is aligned with Federal Enterprise Architecture and Department of Defense Information Enterprise Architecture, which encompasses all components of an integrated IT solution, including new technologies that may emerge during the life cycle of the contract. This GWAC will provide IT solutions through performance of a broad range of services which may include the integration of various technologies critical to the services being acquired.
